## **Advisors' Council Training Committee**

January 25, 2017

- Lindsey reviewed the Spring 2017 training dates, and asked for volunteers to lead the trainings
  - a. Introduction to Advising:
    - i. Tuesday, January 31st: Mary Beth & Lindsey
    - ii. Monday, February 6<sup>th</sup>: Lindsey & Elizabeth
  - b. Advising with Technology:
    - i. Thursday, February 2<sup>nd</sup>: Mary Beth & Elizabeth
    - ii. Wednesday, February 8<sup>th</sup>: Marjorie and Jessica or Lindsey (Lindsey is going to ask Jessica if she can cover; if not, Lindsey will cover it)
  - c. Advising Transfer Students
    - i. Tuesday, March 7th: April & Sevan Paris
    - ii. Thursday, March 9th: April & Sevan
  - d. Mary Beth asked if the presenters can have access to the sign-in sheets; Lindsey showed how to access the sheets as a web editor; Mary Beth offered to look into an easier format with 365 forms
- II. While looking at the website for accessing the sign-in sheets, Marjorie suggested that the Advisement website be updated: 1) there needs to be a link somewhere, because right now there isn't a place students can find the website other than typing in the web address. 2) the "Advisor Information" is misleading and it should be under the student information link
